2018 Window Wonderland Window Painting Recommended Supplies

Recommended Supplies:

Tempera paint (water colors only), assorted colors. You can find Artmind washable tempera primary colors in a 6 pack at Michael's craft stores.

- Assorted paint brushes, paint rollers & sponge brushes
- Box and/or garbage bags for refuse
- Water pail or container
- Rags, wipes or paper towels
- Plenty of newspaper and plastic as a drop cloth
- Empty carton or container with cap for used paint water

Considerations:

- Do not use cleanser since all have abrasive qualities to them and will ruin the glass!!
- PLEASE: NO DARK BACKGROUNDS ARE PERMITTED. Dark backgrounds can cause the windows to crack!!
- The use of stencils and markers is not allowed.
- All paintings must be done free hand with paint and a paintbrush.
- Brush rollers and sponge brushes are acceptable.
- Pencils may be used for outlining purposes only.
- No material should be attached to any painting.
- Window assignments will be emailed on Nov. 7th.

PLEASE READ!!

Assignment #: Tape your child's window assignment on the window you are assigned. Make sure the number on the assignment matches the number on the window. Within the black lines is your designated painting area.

Preparing your window: Please cover the store front, window sills and the ground where you place the paints with newspaper or plastic. Paintings may not be higher than 36" or as marked. If your plans change and you need to cancel (even on the day of the event) call and leave a message at 607-821-8124.

Respect the merchant's windows. Be neat, use paper or plastic around your area and clean up after yourself!! REMEMBER: NO SHOWS AND INDIVIDUALS THAT LEAVE A MESS WILL NOT RECEIVE AN ASSIGNMENT NEXT YEAR!

WAIVER AND RELEASE

2018 Johnson City Window Wonderland Window Painting

In consideration for being able to participate in 2018 Johnson City Window Wonderland Window Painting coordinated, sponsored or affiliated with the Johnson City Partners and My Town A Great Place to Live its employees, agents, sponsors, organizers and event holders (collectively the "sponsors"), the participant and parents on behalf of myself, my heirs, assigns, legal representatives and as legal guardian of any participant or volunteer (collectively "Participant"), agrees to the following terms and conditions ("Agreement"):

1. **Acknowledgment and Assumption of Risk.** Participant acknowledges 2018 Johnson City Window Wonderland Window Painting may pose a risk of serious injury, and property loss and Participant freely assumes the risk of any and all injuries that Participant may sustain. Participant and parents hereby acknowledge, recognizes and assumes all of the risks of participating in this event. Participant realizes that his/her injury, death or property loss may arise from negligence or carelessness on the part of the Johnson City Partners and My Town A Great Place to Live from or related to dangerous or defective equipment, property owned, maintained or controlled by the Village or private party because of any other actions, inactions, carelessness, recklessness or negligence on the part of the Village or other participants. Participant and parents understand that My Town A Great Place to Live magazine does not carry insurance to cover all or some of Participant's and families potential damage or injury and Participant understands that he or she will need to have his or her own insurance coverage in case of any injuries. Participant and parents acknowledge this agreement form will be used by event holders, sponsors, and organizers, for events in which Participant may participate and that it will govern Participant's actions and responsibilities at said events.
2. **Release of Liability and Indemnification.** Participant and parents hereby waives, releases, and discharges, on behalf of Participant and Participant's executors, administrators, heirs, next of kin, successors, and assigns, the Johnson City Partners and My Town a Great Place to Live, its council members, employees, instructors, volunteers, agents, event holders, event promoters, event sponsors, event volunteers, event permit grantors, event property owners, and event participants (collectively "the Releasees"), from any and all liability for Participant's death, disability, personal injury, property damage, property theft, lost income, or any other losses, costs, or actions of any kind whatsoever, which hereafter may directly or indirectly accrue to Participant by virtue of Participant's participation in the Programs, Participant's volunteering for the Programs, or Participant's travel to or from any activity or event at or related to the Programs, due to the negligence, carelessness, or recklessness of the Releasees or due to any dangerous or defective equipment or property that is owned or that is negligently, carelessly, or recklessly maintained, operated or controlled by the Releasees. Participant hereby agrees to indemnify and hold the Releasees harmless from and against any and all liability, loss, damage or injury as well as all costs and expenses (including attorneys' fees and costs of any suit related thereto), suffered or incurred by Releasees, to the extent arising from any of Participant's actions whatsoever whether now or in the future, including but not limited to negligent, intentional or reckless misconduct, acts or omissions.
3. **Medical Treatment.** In the event of an injury, accident, or illness, Participant hereby consents to receive medical treatment which may be considered necessary or advisable in the judgment of a licensed physician or medically trained personnel.
4. **Use of Likeness.** Participant understands that Participant may be photographed at events and/or related activities held at or related to the Programs. Participant agrees to allow the event holders, producers, sponsors, organizers, and their assigns, without charge, to use Participant's photo, video, or film likeness for any purpose.
5. **Agreement to Be Bound.** Participant certifies that Participant has read and understands the terms of this Agreement, and Participant acknowledges that this Agreement will be relied upon by the Johnson City Partners and My Town a Great Place to Live, its employees, volunteers, agents, event holders, sponsors, and organizers of such activities and events in which Participant participates, and that this Agreement will govern all of Participant's participation, volunteering and all other actions and responsibilities at each such activity or event.
6. **Waiver and Severability.** If any part of this Agreement, for any reason, is declared invalid or void, such declaration shall not affect the remaining portions of the Agreement which shall remain in full force and effect as if this Agreement had been executed with the invalid portion eliminated. If Johnson City Partners and My Town a Great Place to Live decide not to enforce a provision of this Agreement, such decision in favor of non-enforcement shall not constitute a complete and full waiver of the right of the Johnson City Partners in the future to enforce that provision of the Agreement.
7. **Governing Law.** Except to the extent that this Agreement may be governed by any federal law, including federal bankruptcy law, this Agreement shall be governed by, construed and interpreted under, and enforced exclusively in accordance with the laws of the state of New York, and the courts in the state of New York shall have jurisdiction with respect to any dispute arising hereunder.
8. **Term and Scope of Agreement.** This Agreement shall apply to all Programs involving Participant for the entire calendar year of the execution date set forth below. This Agreement shall be construed broadly to provide a release and wavier to maximum extent permissible under applicable law.
9. **Modification or Amendment.** No change, amendment or modification of this Agreement shall be made unless agreed to in writing by Johnson City Partners.
